### AGREEMENT

The person who signs the agreement represents that he/she is authorized to enter into this agreement on behalf of both the exhibitor and the owner of the entered dog. He/she also agrees to the following terms:

1. Exhibitor and owner, whether members of MASCA or not agree to abide by the rules and regulations of MASCA and any other rules or regulations appearing in the premium for this trial.
2. Exhibitor and owner certify that the entered dog is not a hazard to persons, dogs or property.
3. Exhibitor and owner acknowledge all hazards presented by the trial and the trial premises, including but not limited to, trial field, parking area, security measures or lack thereof; and the presence of unfamiliar animals and people. Exhibitor and owner assume the risk of any harm arising from these hazards.
4. Exhibitor and owner release MASCA and will defend and hold MASCA harmless from all present and future loss, injury, damage, claims, demands, and liabilities involving the entered dog; the trial or trial premises. Ex. Should the entered dog injure stock, the owner will pay for veterinarian services. If the injury is severe the owner will pay the market value of the stock.
5. As used here MASCA means the owner and the operator of the trial premises, the Miniature Australian Shepherd Club of America, its affiliate clubs and each of their members, officers, directors, employees, course director, trial committees and agents.
