Application for Litter Registration

Please include the following with the Application:

- A.** If both sire and dam are Miniature Australian Shepherd Club of America (MASCA) registered:
- If not already submitted to MASCA, a copy OFA and CERF certificate(s) on sire and dam for Blue Ribbon Breeder program, if available, and title certificate(s), if you wish title(s) to be included on future pedigrees; and
 - Registration fee (see reverse of Application).
- B.** If either sire or dam is NOT MASCA registered but registered with NAMASCUSA, NSDR (Australian Shepherd or **Australian Shepherds of the miniature variety**, ASCA and/or AKC (**Australian Shepherd**):
- A copy of the non-MASCA registered dog(s) NAMASCUSA, NSDR, ASCA and/or AKC registration certificate(s);
 - A photograph of the non-MASCA registered dog(s) in a standing position from the side;
 - If not already submitted to MASCA, a copy OFA and CERF certificate(s) on sire and dam for Blue Ribbon Breeder program, if available, and title certificate(s), if you wish title(s) to be included on future pedigrees; and
 - Registration fee (see reverse of Application).
- C.** Litters with both sire and dam registered as AKC, ASCA, NAMASCUSA and/or NSDR (Australian Shepherd only) are not eligible for registration unless one or both parents have a **Hardship Registration** with MASCA. In this case the MASCA registration number(s) should be used for the Application.
- D.** Age: Sire and dam must be twelve (12) months or older on date of mating to register the litter with Full Registration privileges. If either sire or dam is not yet twelve (12) months old, but both are at least nine (9) months old on the date of mating, the litter is registered with Provisional Registration privileges. A Provisionally Registered dog must receive permanent passing hip and eye clearances at two (2) or more years of age and pay a \$50 Change of Registration Fee in order to receive Full Registration and litter registration privileges. A Provisionally Registered dog may compete in all MASCA events. If either or both sire or dam is under nine (9) months old on Date of Mating, the litter cannot be registered.

Full Registration
